

SUMMARY ANNUAL REPORT

DECEMBER 31, 2021

This is a summary of the annual report for the 403(b) Defined Contribution Retirement Plan (the Plan) for the Mid-West New Mexico Community Action Program, EIN 85-0204500, for the period January 1, 2021 through December 31, 2021. The annual report has been filed with the US Department of Labor's Pension and Welfare Benefit Administration (PWBA) as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### Basic Financial Statement

Benefits under the Plan are provided by Individually owned, fully vested contracts issued by the Principal Financial Group. Plan expenses were \$414,885. This is included \$44,775 in administrative expenses and \$370,110 in benefits paid to participants and beneficiaries. A total 142 persons were participants in, or beneficiaries of the Plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets was \$4,883,253 as of December 31, 2021 compared to \$4,409,760 as of January 1, 2021. During the year the Plan experienced an increase in net assets of \$473,493. This increase includes net appreciation or depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The Plan had a total income of \$888,378 including employer contribution of \$216,450, and employee contributions of \$246,223, and a net gain from earnings from investments of \$425,705.

The charge to cover copying costs given above does not include a charge for the copying these portions of the report because these portions are furnished without charge.
